Applicants who wish to utilize a temporary sign/ banner shall adhere to the following:

- A lot or unit shall be allowed a maximum of six (6) temporary sign/ banner permits per year, each of which shall be valid for 14 consecutive days, starting from the date of issue.
- All temporary signs / banners may be attached to the exterior wall of a building, beneath a canopy or attached to the ground.
- Outside of the Main Street District, no such sign shall be placed within ten feet of the street right- of- way.
- Maximum 30 square feet allowed.
- **PLANNED CENTER TENANTS ONLY:** All temporary signs/ banners attached to the ground must be within the planned center outside of common areas.
